

Revised AGD Mastership Award Requirements Hours needed in new subject areas

Effective January 1, 2017 any AGD member applying for the AGD Mastership Award (MAGD) must have completed a minimum of 12 hours each in the new Orofacial Pain and Anesthesia, Pain Management, Sedation and Pharmacology areas.

- The 12 required hours in Orofascial Pain can be earned in any delivery method: lecture, handson, self-instruction, teaching or publication.
- The 12 required hours in Anesthesia, Pain Management, Sedation and Pharmacology areas MUST be earned by attending hands-on participation hours.

Members applying for the 2015, 2016 and 2017 Mastership class are not required to meet these new requirements. (*To qualify for the 2017 class members must have met all requirements by December 31, 2016. The new requirements go into effect on January 1, 2017.*)

Keep in Mind:

Until December 31, 2016

- Hours submitted using the new Orofacial Pain codes will be applied to the 180: Myofascial Pain/Occlusion requirements.
- Hours using the new Anesthesia, Pain Managament, Sedation, Pharmacology will be applied either to the 010: Basic Science or 130: Electives requirements
 - Hours earned in the new codes 340, 341, 342, 343 and 349 will be applied to the 130: Electives requirements
 - Hours earned in the new code 344 will be applied to the 010: Basic Science requirements.

Effective January 1, 2017:

- Hours using the new Orofacial Pain codes will be applied to the new 200: Orofacial Pain Requirements
- Hours coded using the new Anesthesia, Pain Management, Sedation, Pharmacology codes will be applied to the new 340: Anesthesia, Pain Management, Sedation, Pharmacology requirements
- Hours coded as 016: Pharmacotherapeutics will be applied to the new 340: Anesthesia, Pain Management, Sedation, Pharmacology requirements. (*Prior to Jan. 1, 2017 these hours were* applied towards the 010: Basic Science requirements.)
- Hours coded as 132: Anesthesia and Pain Control, 134: Prescription Medication Management, 163: Conscious Sedation and 164: Oral Sedation will be applied to the new 340: Anesthesia, Pain Management, Sedation, Pharmacology requirements. (*Prior to Jan. 1, 2017 these hours were* applied towards the 130: Electives requirements.)

By December 31, 2017 hours using the "old" codes will be converted to reflect the new codes found in the 200 and 340 series.
